

Records of the Maricopa County Recorder, Arizona ("Edgewater Condominium Plat"). These Edgewater parking spaces were assigned to the Bridgeview Condominiums pursuant to that certain Designation and Assignment of Parking Spaces For Bridgeview at Hayden Ferry Lakeside, A Condominium recorded concurrently herewith.

D. All LCE Storage Spaces are depicted on the Bridgeview Condominium Plat.

E. Pursuant to Subsection 6(b) of the Declaration, Bridgeview has the authority to amend the Declaration to memorialize the assignment of LCE Parking Spaces and LCE Storage Spaces to Units. This Supplemental Declaration is being recorded to make of public record the assignment of LCE Parking Spaces and LCE Storage Spaces.

DECLARATION:

NOW, THEREFORE, for the purposes set forth above, Bridgeview declares as follows:

1. Definitions. Each defined term used in this Supplemental Declaration (including the Recitals) shall have the meaning set forth in the Declaration, unless specifically and otherwise defined in this Supplemental Declaration.

2. Parking/Storage Spaces. Subject solely to Section 6(b) of the Declaration, and pursuant to the authority of Bridgeview set forth therein, Bridgeview hereby creates a new **Exhibit E** (attached hereto and incorporated herein) to the Declaration in order to memorialize the current assignments of certain LCE Parking Spaces and LCE Storage Spaces shown on the Bridgeview Condominium Plat and the Edgewater Condominium Plat.

Not all parking spaces and storage spaces within Bridgeview Condominiums have been designated and assigned as Limited Common Elements by this Supplemental Declaration; as such, Bridgeview reserves its right to (a) assign such unassigned parking spaces and storage spaces as Limited Common Elements to Units, and (b) reassign parking spaces and storage spaces among the Units that it owns, all in accordance with Subsection 6(b) of the Declaration.

3. Covenants to Run with the Land. The provisions contained in this Supplemental Declaration will constitute covenants running with the land.

4. Declaration Otherwise Unchanged. Except as otherwise set forth herein, the Declaration shall remain unchanged and in full force and effect.

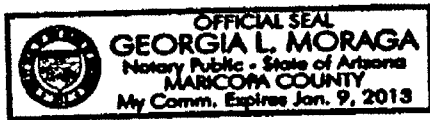

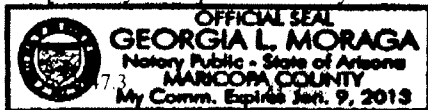
